 The question of population estimations due to sharp increase of migration flows: 1/5 of Georgian population has left during 1990s


Wars and territory changes - After independence, Georgia had to face unresolved conflicts:

➤ 1993-1994: Abkhazia and South Ossetia

➤ 2008: South-Ossetia

Causes of death statistics

Share of class XVIII (Symptoms, signs and abnormal clinical and laboratory findings, not elsewhere classified) in all causes of death



- Goal 1: Universal civil registration of vital events – achieved since 2008
- Goal 2: All individuals are provided with legal documentation of civil registration of vital events – achieved since 2008
- **Goal 3:** Accurate, complete and timely vital statistics (including on causes of death) are produced based on registration records and are disseminated *achieved since 2008 except causes of death*

Strategy for improve the causes of death statistics

It is in progress and hopefully will have success in 2016

- 1. Create the working group: NSO, PSDA and MOH and NCDC with collaboration of WHO
- 2. Ministry of health and NCDC will be responsibility of the collect the data
- 3. To link the morbidity and causes of death
- 4. Adopt the system of Verbal autopsy
- 5. Adopt the institute of "Coroner" public officer whose primary function is to investigate any death thought to be of other than natural causes.

Realization of this plan is mainly depend on the finance
